1. Purpose

The purpose of this document is to set out the principles within which Gulf University conducts graduation ceremonies for eligible students.

2. Scope

The procedures apply to all academic programs at Gulf University.

4. Definitions

Graduate: A person who has successfully completed a course of study or training, especially a person who has been awarded an undergraduate or first academic degree.

Graduation Ceremony: It is the act in which the university degrees and diplomas are conferred to graduates.

Student: Student is an individual who is formally registered in programs offered by Gulf University.

5. Policy Statements

- 5.1 All academic and students' codes of conduct stipulated at Gulf University apply to graduation ceremony day.
- 5.2 GU commits to honor and invites only the eligible graduates to participate in the graduation ceremony.
- 5.3 GU ensures that every student applying for graduation ceremony has successfully completed the degree requirements as per the relevant policies and procedures along with no dues in fees.
- 5.4 GU is committed to planning and execute the graduation ceremony meticulously with full dignity and professionalism.
- 5.5 GU ensures a unified and non-discrimination dress code. This should be stated in the graduation ceremony procedures.

- 5.6 GU ensures that the dress code is binding on every graduate attending the ceremony.
- 5.7 GU is committed to coordinating with the graduates eligible to participate in the ceremony for rehearsal, and instructions for commencement exercise.
- 5.8 GU preserves the right to stop or prevent a graduate who has not registered from participating in the ceremony, or any other reason relevant to violation of the university policies and procedures prior to the ceremony.
